

PROPOSED LOCAL LAW K - 2026

A Proposed Local Law to Amend Sections 326-65, 326-66 and 326-67 of the Code of the Village of Mamaroneck Re: Miscellaneous penalties; Permit parking area; Metered parking zones.

**BE IT ENACTED by the Board of Trustees of the Village of Mamaroneck as follows:**

*Section 1.*

Chapter 326, Article VII, Section 326-65 of the Code of the Village of Mamaroneck is hereby amended to read as follows:

“§ 326-65 Miscellaneous penalties.

...

- B. In addition to any penalty provided by the Vehicle and Traffic Law, any person violating any of the provisions of § 326-4 or Article III of this chapter shall, upon conviction, be punished for the first offense by a fine not exceeding ~~\$25~~, **\$35**, for the second offense by a fine not exceeding ~~\$35~~ **\$45** and for any subsequent offense by a fine not exceeding ~~\$45~~ **\$55**, **except that any person violating any of the provisions of § 326-22 or § 326-23 shall, upon conviction, be punished by a fine not exceeding \$150.**

...”

*Section 2.*

Chapter 326, Article VII, Section 326-66 of the Code of the Village of Mamaroneck is hereby amended to read as follows:

“§ 326-66 Permit parking areas.

- A. Downtown, commercial and related permit parking areas (e.g. GP, RP, RR, CV, etc.): Any person violating any provisions of Article IV of this chapter in relation to downtown, commercial and related permit parking areas, except § 326-49F, G and H, and § 326-66B, may, upon conviction, be punished by a fine not exceeding ~~\$25~~ **\$75**. **Any person violating any provisions of § 326-49F may, upon conviction, be punished by a fine not exceeding \$150.**
- B. Boat trailer permit parking only area: Any person violating any of the provisions of Article IV of this chapter in relation to boat trailer or boater permit parking only, ~~except or~~ § 326-49G and H **only**, may, upon conviction, be punished by a fine not exceeding ~~\$50~~ **\$100**.

*Section 3.*

Chapter 326, Article VII, Section 326-67 of the Code of the Village of Mamaroneck is hereby amended to read as follows:

“§ 326-67 Metered parking zones.

- A. Any person violating any of the provisions of Article V of this chapter, ~~except §§ 326-59G and 326-61,~~ may, upon conviction, be punished for the first offense by a fine not exceeding ~~\$25~~ **\$35**; and for the second offense within a twenty-four-hour period by a fine not exceeding ~~\$35~~ **\$45**; and for any subsequent offense within a twenty-four-hour period by a fine not exceeding ~~\$45~~ **\$55**.

...”

*Section 4.*

If any section, subsection, clause, phrase or other portion of this local law is, for any reason, declared invalid, in whole or in part, by any court, agency, commission, legislative body or other authority of competent jurisdiction, the portion of the law declared to be invalid will be deemed a separate, distinct and independent portion and the declaration will not affect the validity of the remaining portions hereof, which will continue in full force and effect.

*Section 5.*

This law is adopted pursuant to the authority granted by Municipal Home Rule Law § 10(1)(e)(3). It supersedes the provisions of the Village Law, including those provisions which provide for the approval of a land use application on the basis of the passage of time, and the Code of the Village of Mamaroneck, including those provisions which authorize or require the approval of a land use application, to the extent that they are inconsistent with this local law.

*Section 6.*

This local law will take effect immediately upon its filing in the office of the Secretary of State in accordance with Municipal Home Rule Law § 27.
