Comparison of Total Costs (3-Year Rental + Buyout)

The total cost of ownership for the three-year rental term (2025–2027) plus the Village Buy Option in 2028 varies between proposals due to differences in pricing, discounts, and buyout structures:

While the September 24th proposal reduces the four-year cost by approximately \$6,744.00, staff identified significant tradeoffs in value and scope.

Value Assessment and Item Inclusions

I. Cost Components and Discounts

- 1. **Client Discount:** The \$60,550 proposal included a \$10,000 client discount. The \$53,897 revision removed this discount.
- 2. **Buyout Savings:** The \$60,550 proposal offered a flat-rate buyout of \$10,000, saving \$18,590.75 compared to the standard 15% buyout (\$28,590.75). The \$53,897 revision reverted to the standard 15% buyout (\$25,286.10), increasing costs by \$15,286.10 over the flat-rate option.

II. Decorative Items and Scope of Work

The main tradeoff in the lower-cost revision was a significant reduction in decorative elements, particularly at Harbor Island Park:

The removed items in the \$53,897 proposal were valued at approximately \$16,500.

Staff Recommendation: Best Value for the Money

Staff recommends proceeding with the \$60,550 proposal for year one, based on the following rationale:

- 1. **Nominal Cost Difference:** The total four-year cost differs by only \$6,744 (\$1,686 per year), which is minor compared to the overall project cost adds holiday lighting elements to the harbor.
- 2. **Balanced Value:** It balances cost savings with maintaining the quality and visual impact of the holiday display.
- 3. **Preserves Key Elements:** It retains essential decorative elements at Harbor Island Park's entrance and pavilion.
- 4. **Maintains Full Scope:** Includes the full range of original items, including the complimentary 6' menorah, and preserves the \$10,000 client discount.

5. **Maximizes Overall Value:** Leveraging Village staff for installation and retaining the flat \$10,000 buyout achieves significant savings while maintaining the integrity and appeal of the display.

The \$60,550 proposal represents the most cost-effective option among all submissions, delivering a visually impressive holiday experience at a substantially reduced cost.
