Re: Water rate increase

On March 10th David Birdsall from Westchester Joint Water Works gave a presentation to the Board of Trustees noting the need for an additional water rate increase of 15% – 20%. The main driver of this increase being the upcoming debt service cost related to the \$205 million water filtration plant.

Factors determining the requested water rate increase:

- Debt service related to the \$205m water filtration plant construction at Rye Lake (the cost of which will be offset by a \$30 million EFC grant).
- Debt service for related water system capital projects
- Increasing operational costs driven by regulatory requirements, technology upgrades and continuing supply chain driven costs
- Increasing NYC upstate water rates
- To maintain the Water Fund surplus (fund balance) for contingencies

The debt service related to the filtration plant will consist of VOM share of the \$145 million EFC loan, related fees, and any unfunded project related expenses.

Estimated Annual Water Fund Debt Service costs:

As of 5/31/2025, the Water Fund has an approximate fund balance of \$3 million. The proposed rate increase will help to maintain a healthy fund balance to be used for contingencies and to offset the need for bonding of future water fund projects.

I agree with Mr. Birdsall that a rate increase of 20% is needed at this time to support the ongoing improvements to the water system infrastructure in the Village. By using short-term financing and spreading the debt issuance over the course of the project term, the 20% increase should be sufficient to cover the Water Fund expenses. In August 2030, Bond Series 2019 will fully mature and reduce the Water Fund debt service payment by \$300k.

I continue to work with our bond council to determine the best method of funding these costs, either by long- or short-term funding or the use of fund balance. The funding or a portion thereof will begin toward the end of this calendar year.
