Mr. Strome:

As we discussed on our call Wednesday, final DEC/DOH comments regarding the draft Site Management Plan (SMP) were provided to the Village's environmental consultant LaBella at the end of April, with a follow-up discussion regarding the comments in early May. My understanding is LaBella has addressed the state's comments and their Professional Engineer is currently reviewing the SMP prior to providing the necessary certification. The certified SMP will then be submitted to DEC/DOH for final agency review, DOH concurrence, and DEC approval.

In the near term, per the SMP, the following activities need to be performed:

- Zion Environmental submitted the December 2023 Site Monitoring Results on July 18, 2024;
- the next round of environmental monitoring for the site is planned for the 3rd quarter of 2024;
- annual site-wide inspection, coincident with the planned environmental monitoring of the site; and
- submittal of the initial periodic review report in early 2025.

Landfill maintenance items identified in the SMP that will eventually need to be addressed:

- completion of the boundary security fence surrounding the landfill;
- address soil pile encroaching on the landfill cap from the operations of the north-adjacent nursery / garden center (needs to be resolved prior to completing the perimeter fence installation); and

• repairs to protective structures around the gas vents located on the landfill.
